## Important Notification: LLB Application to Open on Monday, 10-3-16, and Tuesday, 10-4-16 (3P)

Per the broadcast notice that was sent out earlier this week, the Management and Marketing (M&M) 3.7 Asset Management (AM) contract corresponding to the 3P region (CT, MA, ME, NH, NJ, NY, VT, RI) will imminently be transferred to **BLB Resources**.

In light of this upcoming transition, BLB Resources will be seeking LLB applicants located within the 3P area to establish our new network of HUD LLBs. Please note that the LLB application for agents/brokers located in the 3P contract area will be made available on **Monday, 10-3-16, and Tuesday, 10-4-16**. The LLB application will only be made available for all of the 3P states during these two days. Agents/Brokers who fail to submit an LLB application within the allotted timeframe will not be considered for BLB's HUD LLB network.

In order to access the LLB Application form, you must first register onto our website and create a BLB Username and Password. Please click the link below in order to begin your account registration with BLB Resources. Once you have registered accordingly, you will be taken to the "Vendor Network" portal tab on our main page, where you will have access to complete the LLB application accordingly.

Our website and Vendor Network portal is best compatible with the following web browsers:

- Microsoft Internet Explorer (11+), Google Chrome (version 32+), Apple Safari (version 5.1.7+)
- May not be compatible with Firefox web browser

Once again, you must register onto our website first in order to submit the online application. **If you have already registered on our website during the past few days, then please make sure to log into the "Vendor Network" portal directly.** Please make sure to log in using the username and password that you created when you first registered.

We will carefully analyze and evaluate all LLB applicants through our extensive application process. Our upcoming LLB application may take up to an hour or more to complete. We highly recommend that applicants thoroughly review the entire application once it is available, and collect the requisite information in order to complete it in a timely manner. For example, applicants will be asked to upload the following documents in PDF format when completing the online application form:

- W-9 Form
- Errors & Omissions Insurance Policy
- General Liability Insurance Policy
- Worker's Compensation Policy
- Copy of Broker's License
- Copy of Real Estate License
- Examples of advertising and other marketing materials



It is very important that you thoroughly read and review all of the information and instructions contained in the LLB application. We will only contact and follow-up with agents/brokers that have been accepted into our network. We will begin our selection process after the application is closed on Tuesday, 10-4-16.

PLEASE NOTE:

- At this time, BLB Resources has not fully taken over the M&M 3.7 contract in the 3P area. As such, we still do not have access to all of the existing files in that HUD inventory. If you are an existing LLB for the current AM in the 3P contract-area, Sage Acquisitions, or if you are a Selling Agent with an existing contract or inquiry on any of the HUD listings in those states, please refer to Sage Acquisitions accordingly.
- All existing LLBs contracted with Sage Acquisitions must re-apply with BLB Resources
