Important Notification: Asset Management Change (4D)

The Management and Marketing (M&M) Asset Management (AM) contract corresponding to the 4D region (IA, NE, SD, WI) will imminently be transferred to **BLB Resources, Inc.**

In light of this upcoming transition, BLB Resources will be seeking Local Listing Broker (LLB) applicants located within the 4D area to establish our new network of HUD LLBs. We will be sending out a **second broadcast notice** informing you of the **LLB application** availability and timeframe. We look forward to providing you with additional detailed information regarding the process of how you can submit your new LLB application to us for this contract. We welcome your applications.
